10. New Business

- a. Victoria dances: Wyatt learned that the organizer for Victoria's dance is moving. There is interest in BCSDC becoming a sponsor. Bob and Caroline will continue to participate in the organizing. Details need to be discussed regarding teaching and financial matters. **Motion** by Wyatt, Amanda :Authorize Wyatt to arrange for BCSDC to host regular weekly dances on Saturday nights in Victoria. Passes unanimously.
- b. Shutting registration desk early. Create a sign to see the DJ to sign the waiver and pay. Will experiment with making announcements at the dance earlier. Will close the desk around 9:30.
- c. Additional April dance. There are seven weeks between the March dance and the one scheduled for April. Currently planning two dances in May. No additional dance is planned.
- d. Westies bombing Fairview Pub. Suggested that board members try out the place, with Tuesday March 26 or April 2 suggested. If it looks good, then music will be discussed with the managers.
- e. First dance free. Available to visitors from out of town or other first time attendees. **Motion**, by Rick and Amanda: A person coming to the dance for the first time will be allowed into the social dance for free. Passes unanimously.
