#### 9. Committee Updates

- a. May Workshop Committee. Wyatt coming along well: Instructors arranged, Vickie will get a 2 veggie trays and 2 fruit trays, James will DJ, the club will rent music equipment (Wyatt and Amanda). Question: demo (100) or choreographed routine (150)? Decision: No demo. Advertise again and offer sign-up at the May 11 dance (front desk and announcements).
- b. Summer BBQ / Picnic Committee. Announce at dances, August 24 from 5 to 7. Vickie preparing lists for shopping. Music will be brought by Crystal.
- c. Victoria Committee. Four dances so far, with Sam and Meagan instructing. The instructors are moving, however. Continuing without a loss. Space is small, floor and sound system are good. Webmail sub-group is set up in mail chimp (30 to 40 names). Dance numbers vary but 25 to 40 so far. June will have one workshop with practice hours the other weeks.

#### 10. New Business

- a. Review of Abbotsford / Aldergrove dance venue trial. Meeting beforehand was nice. The cost was very good. The floor was too firm. The sound system was usable but not, by itself, sufficient. The board will continue looking for venues. Might try Coghlan Hall or the Aldergrove Legion.
- b. Fairview Pub. Some board members visited on a Tuesday when live music was playing. Space for 3 or 4 couples. Music was mostly not WCS. Might look for other venues.
- c. Dance scholarships. A member asked for support to attend a workshop. If the club supports members in this type of activity, then we need a policy that can be applied equitably. Decision was that we have better ways to support the local dance community.
- d. Summer dance. Rick examined the possibility of using Rhodes College. Considering a 2 hour Flashmob class on July 20th, followed by a dance. Need to deal with entry into the building (must be buzzed in), parking is an issue. The sound system is good in the main hall. The floor is hard. Alternatives include the Polish Hall (used for Bameo), Coal harbor or Granville Island community centers if not charging admission. Amanda will contact the Polish Hall. Others will continue working.
- e. Flashmob / Rally. Choreography will be out Wednesday. Michael will be willing to teach June 15th if we can get the space from 6 to 7. July 20th, a two hour workshop. Rick will discuss with potential instructors. We could subsidize practice space for the Flashmob, if that is needed.
