8. Event Review

- a. Financial Report: Revenue \$1,957, Expenses \$1,150, Income \$807
- b. Attendance
 - i. Beginner Lesson: 34 attendeesii. Intermediate Lesson: 50 attendees
 - iii. Dance: ~120 attendees
- c. Dance Overview
 - i. Front desk are we keeping it open until 10 pm?
 - Yes. Last month and this month, there were a few people still trying to gain entry between 9:30 and 10pm. Enough to keep it open until 10pm, but not enough to warrant keeping it open past that.
 - ii. Should we take photos at events to post on social media (with permission from the people in the photos)?
 - May require people to sign a waiver. But since other studio's and venues
 do this freely, it may not be required by law. We have waivers and signs
 to use from back when our insurance required it. Stopped using them
 because insurance no longer requires it and the Club doesn't typically
 take pictures. Some people brought up that it may not be legally
 required.
 - a. Tori will ask her connection if a waiver/notice is legally required.
 - There is a culture among other venues to freely post pics and videos to social media.
 - a. People may already be okay with this practice, but the club will respect anyone who comes forward with their wish to, not be in the picture, or posted online.
 - Since it's our last night here, we shouldn't make too many changes.
 - iii. What percentage of the students in the beginner class stayed for the dance? We direct people into the beginner class as quickly as we can and encourage them to come back and pay for the dance, but do they stay? Can we do anything differently here?
 - Discussion:
 - a. At least a few people, between 3-5, stay a bit for the dance.
 - b. Possible Sliding Scale option.
 - c. Most agreed to keep it free.
 - d. It would be nice to electronically track how many beginners came.
 - iv. There were a few questions regarding the July and August dances, as well as the location of Christine Sinclair.



- Is there a dance in July, are we doing anything in August, what happens in September, where is Christine Sinclair, what is the dance space like at CS and is it big enough, what happens in 2025?
 - a. Lauren will adjust the Facebook event image to show the event location for each dance.
- v. Some people still don't know that we're moving from Confed. What can we do to increase awareness?
 - We've already put it in our announcements, Newsletter, Facebook, and Instagram. If some people aren't paying attention to our channels, there isn't much more we can do. For now, we'll continue to repeat the message among our channels.
